## NBWW MONITORING COMMITTEE MEETING MINUTES

### 1. Call Meeting to Order

Introductions & Roll Call

Rob Flood, North Branch Chicago River Watershed Workgroup (NBWW) Monitoring Committee Chair, called the NBWW Monitoring & Water Quality Impairment Abatement Committee meeting to order at 1:02pm.

Monitoring Committee members present were **Rob Flood**, North Shore Water Reclamation District (NSWRD); **Kate Amoruso**, Village of Wilmette; **Larry Bridges**, East Skokie Drainage District; **Sam Barghi**, Village of Lincolnshire; and **Leonard Dane**, Fehr Graham Engineering & Environmental. **Steve Silic**, Forest Preserve District of Cook County (FPDCC) attended virtually and did not vote. A roll call and introductions were performed.

Bridges motioned to accept the March 09, 2022, NBWW Monitoring & Water Quality Impairment Abatement Committee Meeting Minutes, seconded by Dane. The motion passed with a unanimous vote.

### 4. Old Business

- a. **Introduce Mia Gerace**: Mia Gerace, SMC Stormwater Coordinator, was introduced to the Committee members and will be the NBWW Coordinator during Ashley Strelcheck's maternity leave.
- b. NBWW NARP RFP Revisions & Recommendations to Executive Board: In compliance with the Open Meetings Act, StreIcheck solicited comments from Committee members individually via email in advance of the meeting. Comments were added to a draft version of the RFP and were reviewed by the meeting attendees.
  - i. **Interview and Evaluation Team:** Flood, Bodden and Michele Mrachek (ESDD Monitoring Committee Alternate) volunteered to be a part of the NBWW NARP Consultant Interview and Evaluation Team.
- c. In-Person vs. Virtual Monitoring Committee Meetings: Strelcheck briefed the Committee on the current guidance on virtual meetings based on feedback from the State's Attorney. The current guidance states that the need to meet virtually must be warranted by an emergency. Members who attend virtually are not able to vote. The Committee will revisit this topic at the June meeting and consider drafting a policy for review by the Executive Board that would allow voting members who attend virtually to vote if they are not able to attend in person due to an emergency, illness, or other compromising circumstance.
- **5. New Business:** Flood noted that the Illinois EPA NPDES Annual Monitoring Report for the North Branch Chicago River Watershed Workgroup was sent to the Illinois EPA at the end of March.
