NBWW MONITORING COMMITTEE MEETING MINUTES

1. Call Meeting to Order

Introductions & Roll Call

Josephine Meincke, North Branch Chicago River Watershed Workgroup (NBWW) Monitoring Committee Chair Alternate, called the NBWW Monitoring & Water Quality Impairment Abatement Committee meeting to order at 12:39pm.

a. NBWW 2022 Annual Newsletter Review

b. NARP Update

Ashley Strelcheck, NBWW Coordinator, explained that the NSWRD, Village of Deerfield and Geosyntec had a phone call with the Illinois EPA to request a NARP extension for their NPDES permits. A formal letter is being drafted from the two wastewater treatment plants to the Illinois EPA formally requesting an extension from December 31, 2024 to December 31, 2025 with a list of reasonings. The NBWW will be updated when a response is received from the Illinois EPA. The workgroup will continue with the 2023 monitoring strategy and NARP scope of work.

5. New Business

a. NBWW 2022 Workplan & Scorecard Recommendation to Executive Board

Strelcheck presented the draft NBWW 2022 workplan and scorecard to the Monitoring Committee for comments or revisions. There were no comments or revisions at this time.

b. NBWW 2023 Monitoring Strategy Review

Strelcheck presented a draft 2023 NBWW Monitoring Strategy with redline revisions and comments. The Monitoring Committee requested that Strelcheck accept the revisions and keep any remaining comments
